## EXECUTIVE ORDER D-279-7

## Relating to Exemptions Under Section 27156 of the California Vehicle Code

## COMP Performance Group LSXR Intake Manifold

Pursuant to the authority vested in the Air Resources Board by Section 27156 of the Vehicle Code; and

Pursuant to the authority vested in the undersigned by Section 39515 and Section 39516 of the Health and Safety Code and Executive Order G-02-003;

IT IS ORDERED AND RESOLVED: That the installation of the LSXR Intake Manifold, manufactured and marketed by COMP Performance Group, 3406 Democrat Road Memphis, Tennessee 38118, has been found not to reduce the effectiveness of the applicable vehicle pollution control systems and, therefore, is exempt from the prohibitions of Section 27156 of the Vehicle Code for the following vehicle applications:

\* Requires an injector spacer kit, part no. 146025-kit, if equipped with an LS3 engine.

The LSXR Intake Manifold is a replacement intake manifold. No modifications are made to any original equipment part for proper installation except for the injector spacer kit as designated above.

This Executive Order is valid provided that the installation instructions for the LSXR Intake Manifold will not recommend tuning the vehicle to specifications different from those of the vehicle manufacturer.

Changes made to the design or operating conditions of the LSXR Intake Manifold, as exempt by the Air Resources Board, which adversely affect the performance of the vehicle's pollution control system shall invalidate this Executive Order.

This Executive Order shall not apply to any LSXR Intake Manifold advertised, offered for sale, sold with, or installed on a new motor vehicle prior to or concurrent with transfer to an ultimate purchaser.

Marketing of the LSXR Intake Manifold using any identification other than that shown in this Executive Order or marketing of the LSXR Intake Manifold for an application other than those listed in this Executive Order shall be prohibited unless prior approval is obtained from the Air Resources Board.

This Executive Order does not constitute any opinion as to the effect the use of the LSXR Intake Manifold may have on any warranty either expressed or implied by the vehicle manufacturer.

This Executive Order is granted based on submitted emission test data generated on a 2010 model year Chevrolet Camaro (AGMXV06.2089, LEV II ULEV, PC), modified with the LSXR Intake Manifold. Test results showed that emission levels, with the LSXR Intake Manifold installed, were below the emission standards when tested using Cold-Start CVS-75 Federal Test Procedure and the Supplemental Federal Test Procedure (US06) test cycle. Results from emission testing conducted at Automotive Testing and Development Services, Inc., 400 South Etiwanda Avenue, Ontario, California 91761, are shown below, in grams per mile, with deterioration factors (df) applied.

No claim of any kind, such as "Approved by the Air Resources Board", may be made with respect to the action taken herein in any advertising or other oral or written communication.

iolation of any of the above conditions shall be grounds for revocation of this order. The order may be revoked only after a ten-day written notice of intention to revoke the order, in which period the holder of the order may request in writing a hearing to contest the proposed revocation. If a hearing is requested, it shall be held within ten days of receipt of the request and the order may not be revoked until a determination is made after the hearing that grounds for revocation exist.
