## EXECUTIVE ORDER D-338-73 Relating to Exemptions Under Section 27156 of the Vehicle Code

## Harley-Davidson Motor Company Screamin' Eagle Air Cleaner Kit

Pursuant to the authority vested in the Air Resources Board (ARB) by Vehicle Code (VC) Section 27156; and

Pursuant to the authority vested in the undersigned by Section 39515 and Section 39516 of the Health and Safety Code and Executive Order G-14-012;

IT IS ORDERED AND RESOLVED: That the installation of the Screamin' Eagle Air Cleaner Kit (Kit), marketed and manufactured by the Harley-Davidson Motor Company, 3700 W. Juneau Avenue, Milwaukee, Wisconsin 53208 has been found not to reduce the effectiveness of the applicable vehicle pollution control system and, therefore, is exempt from the prohibitions of VC Section 27156 for applicable 2015 model year Harley-Davidson Street model motorcycles with either a 494 cc or 749 cc engine.

The Harley-Davidson Kit, part number 29400197, replaces the OEM air cleaner assembly, including backplate and mounting bracket. This is an air cleaner kit only, no ECM calibration.

This Executive Order is valid provided that the installation instructions for the Kit will not recommend tuning the motorcycle to specifications different than those set by the Harley-Davidson Motor Company.

Changes made to the design or operating conditions of this Kit, as exempted by ARB, which adversely affect the performance of the motorcycle's pollution control system shall invalidate this Executive Order.

Marketing of the Kit using any identification other than that shown in this Executive Order or marketing of the Kit for an application other than those listed in this Executive Order shall be prohibited unless prior approval is obtained from the ARB.

This Executive Order does not constitute any opinion as to the effect the use of this Kit may have on any warranty either expressed or implied by the Harley-Davidson Motor Company.

This Executive Order is granted based on the submitted emissions test data from Harley-Davidson on two 2015 model year Harley-Davidson Street motorcycles, modified with the Screamin' Eagle Air Cleaner Kit.

Test results have shown that emission levels, with the modified part installed, met the applicable emission standards when tested using the Cold-Start CVS-75 Federal Test Procedure (FTP) test cycle. Results from emissions testing conducted at Harley-Davidson Motor Company's Milwaukee, Wisconsin emissions laboratory are shown below (in grams per kilometer).

No claim of any kind, such as "Approved by the Air Resources Board", may be made with respect to the action taken herein in any advertising or other oral or written communication.

Violation of any of the above conditions shall be grounds for revocation of this order. The order may be revoked only after a ten-day written notice of intention to revoke the order, in which period the holder of the order may request in writing a hearing to contest the proposed revocation. If a hearing is requested, it shall be held within ten days of receipt of the request and the order may not be revoked until a determination is made after the hearing that grounds for revocation exist.
