EXECUTIVE ORDER D-427-7

Relating to Exemptions Under Section 27156
of the California Vehicle Code

Northern California Diagnostic Laboratories, Inc.
96 Cubic Inch Stage 2 Map Kit

Pursuant to the authority vested in the Air Resources Board by Section 27156 of the Vehicle Code; and

Pursuant to the authority vested in the undersigned by Section 39515 and Section 39516 of the Health and Safety Code and Executive Order G-02-003;

IT IS ORDERED AND RESOLVED: That the installation of the 96 Cubic Inch Stage 2 Map Kit, produced and marketed by Northern California Diagnostic Laboratories, Inc. of 2748 Jefferson Street, Napa, California 94558, has been found not to reduce the effectiveness of the applicable vehicle pollution control systems and, therefore, is exempt from the prohibitions of Section 27156 of the Vehicle Code for 2007 model year non-catalyst equipped Harley-Davidson Touring, Softail, and Dyna motorcycle models with an engine test group of 7HDXC1.58AEC, as listed on the motorcycle's tune-up label.

The 96 Cubic Inch Stage 2 Map Kit includes a new ECU calibration, a Harley-Davidson Screamin Eagle Air Filter (Screamin Eagle Air Filter, Part No. 29440-990 fits Dyna and Softails models, and 29441-99A fits Touring models) and a new set of Screamin Eagle Mufflers (**Touring Part Nos.** : 64985-07, 80490-07, 80491-07, **Dyna Part Nos.:** 805492-07, 80493-07, **Softail Part Nos.:** 80494-07, 80495-07, 80496-07, 80497-07, 80500-07, 80501-07, 80498-07, 80499-07), an exhaust baffle, Screamin Eagle 251 Camshaft Kit, Part No. 25466-00, JE Piston Kit, Part No. 265381, Screamin Eagle Tappets, Part No. 18562-02, Screamin Eagle Pushrod Kit, Part No. 17997-99A, Screamin Eagle Clutch Spring, Part No. 37882-06, and Camshaft Bearings, Part No. 9215. The new ECU calibration is downloaded to the motorcycle's ECU and can only be installed by either a Harley-Davidson dealer, Northern California Diagnostic Laboratories, Inc., or an authorized representative. The new ECU calibration has no dealer or user adjustments. Installation does not require modification or relocation of any engine or emission control system component.

This Executive Order is valid provided the installation instructions for the 96 Cubic Inch Stage 2 Map Kit will not recommend tuning the vehicle to specifications different from those of the vehicle manufacturer.

Changes made to the design or operating conditions of the 96 Cubic Inch Stage 2 Map Kit, as exempt by the Air Resources Board, which adversely affect the performance of the vehicle's pollution control system shall invalidate this Executive Order.

This Executive Order shall not apply to any 96 Cubic Inch Stage 2 Map Kit advertised, offered for sale, sold with, or installed on a new motor vehicle prior to an ultimate purchaser.

Marketing of the 96 Cubic Inch Stage 2 Map Kit using any identification other than that shown in this Executive Order or marketing of the 96 Cubic Inch Stage 2 Map Kit for an application other than those listed in this Executive Order shall be prohibited unless prior approval is obtained from the Air Resources Board.

This Executive Order does not constitute any opinion as to the effect the use of the 96 Cubic Inch Stage 2 Map Kit may have on any warranty either expressed or implied by the vehicle manufacturer.

This Executive Order is granted based on submitted emission test data generated on a 2007 model year Harley-Davidson Touring model with engine family 7HDXC1.58AEC. Test results showed that emission levels, with the 96 Cubic Inch Stage 2 Map Kit installed, met the applicable emission standards when tested using the Cold-Start CVS-75 Federal Test Procedure (FTP). Results from emission testing conducted at Northern California Diagnostic Laboratories, Inc., located in Napa, California, are shown below in grams per kilometer, with deterioration factors (df) applied.



No claim of any kind, such as "Approved by the Air Resources Board", may be made with respect to the action taken herein in any advertising or other oral or written communication.

Violation of any of the above conditions shall be grounds for revocation of this order. The order may be revoked only after a ten-day written notice of intention to revoke the order, in which period the holder of the order may request in writing a hearing to contest the proposed revocation. If a hearing is requested, it shall be held within ten days of receipt of the request and the order may not be revoked until a determination is made after the hearing that grounds for revocation exist.
